## 2024 Annual General Meeting

I am pleased to be writing to you with details of our Annual General Meeting (“AGM”) which will take place at 11:30am on 31 July 2024 at the offices of Howard Kennedy LLP at 1 London Bridge, London SE1 9BG. The formal Notice of AGM is set out on pages 6 to 8 of this document.

We are looking forward to seeing as many Shareholders as possible in person at this year’s AGM. However, we appreciate that some Shareholders value the convenience of virtual attendance, therefore, Shareholders will also have the option to view and listen-in to the meeting remotely via a Zoom webinar facility, which can be accessed from any computer with internet access or through a telephone (mobile or landline). Shareholders taking part via the Zoom webinar facility will not be able to speak at the meeting or vote on the AGM resolutions, but will be able to observe the formal business of the meeting and listen to the Manager’s update.

Shareholders are required to register their attendance via the Zoom facility in advance of the meeting, through the Manager’s website. After verification of their identity, details of how to join the Zoom webinar will be provided to each Shareholder. Further information is available on the Manager’s website at <https://www.mercia.co.uk/vcts/n2vct/>.

The purpose of this document is to set out the background to and reasons for the Resolutions which are to be proposed at the AGM and to explain why the Directors consider them to be in the best interests of the Company and Shareholders and recommend that you vote in favour of the Resolutions.

Explanatory notes on all the business to be considered at this year’s AGM appear on pages 3 to 5 of this document.

## Action to be taken by Shareholders

If you would like to vote on the Resolutions but will not be in physical attendance at the meeting, you should complete the Form of Proxy attached to this notice and return it to the Company’s registrars, The City Partnership (UK) Limited at The Mending Rooms, Park Valley Mills, Meltham Road, Huddersfield HD4 7BH as soon as possible. They must receive it no later than 11:30am on 29 July 2024. Completion and return of the Form of Proxy will not preclude you from attending the AGM and voting in person should you so wish. If you would like to vote by proxy online you can do so by accessing the ‘Vote Here’ button on the Manager’s website at <https://www.mercia.co.uk/vcts/n2vct/>.

## Recommendation

Your Board considers that all the Resolutions to be put to the meeting are in the best interests of the Company and its Shareholders as a whole and are most likely to promote the success of the Company for the benefit of its Shareholders, and unanimously recommends that you vote in favour of the Resolutions. ## Explanation of the business to be considered at the 2024 Annual General Meeting

All Resolutions will be proposed as ordinary resolutions, unless otherwise mentioned. For an ordinary resolution to be passed, more than half of the votes cast (in person or by proxy) must be in favour of the Resolution. For a special resolution to be passed, at least three-quarters of the votes cast (in person or by proxy) must be in favour of the Resolution.

### Resolution 1: Receipt of the accounts

The Company is required by law to put the Company's annual report and financial statements for the year ended 31 March 2024 before the meeting. Shareholders are invited to vote to receive and approve the Company's annual report and financial statements for the year ended 31 March 2024 together with the strategic report, Directors' report and independent auditor's report thereon.

### Resolution 2: Approval of final dividend

Shareholders are being asked to approve a final dividend of 1.2p per Ordinary Share in respect of the year ended 31 March 2024. If Shareholders approve the recommended final dividend, this will be paid on 23 August 2024 to all Shareholders who were on the register of members on 26 July 2024.

### Resolution 3: Approval of the Directors' remuneration report

The Company is required by law to seek Shareholders' approval of the Directors' remuneration report in respect of the year ended 31 March 2024, which is set out on pages 42 and 43 of the Company's annual report for the year ended 31 March 2024. Whilst the payment of remuneration to the Directors is not dependent on the passing of the Resolution, your Board will take the vote into account when considering the future development and operation of the Company's remuneration policy and practice.

The Company is also required by the Act to seek Shareholders' approval of the Directors' remuneration policy as set out in the Directors' remuneration report at least every three years, or in the event of a change in the policy if sooner. The Directors' remuneration policy was approved by Shareholders at the annual general meeting held in July 2023 and, unless there is a change in the policy, it is the current intention of the Directors that a resolution for the approval of the Directors' remuneration policy will next be considered at the annual general meeting to be held in July 2026 (being the third annual general meeting since it was last approved).

### Resolutions 4 to 8: Re-appointment and appointment of Directors

The Board has determined that, in accordance with the AIC Code, all Directors should retire on an annual basis. Consequently, Mr D P A Gravells, Mr S P Devonshire, Miss C A McAnulty and Miss R K Ramparia retire from the Board and seek re-election. It is noted that Mr D P A Gravells and Miss C A McAnulty have served as a Director for more than nine years.

Mr Thomas Chambers was appointed to the Board on 19 June 2024 and is seeking election by Shareholders.

Your Board believes that each of the Directors makes a relevant and significant contribution to the operation of your Board and displays an appropriate level of knowledge and experience.

#### Resolution 4: Re-appointment of Mr D P A Gravells as a Director

Mr David Gravells was appointed to the Board in 2007 and became Chair in 2008. He is Chair of the management engagement committee and the nomination committee and is a member of the audit committee.

Mr Gravells is an experienced entrepreneur who has been involved in a wide range of private equity financed businesses. He is a portfolio consultant to a number of developing companies and has interests in the public sector.

#### Resolution 5: Re-appointment of Mr S P Devonshire as a Director

Mr Simon Devonshire OBE was appointed to the Board in January 2017. He is a member of the audit committee, the nomination committee and the management engagement committee.

Mr Devonshire has extensive business experience in corporate leadership, financial governance, strategy, communications and sales and marketing. He is currently entrepreneur in residence at the National Physical Laboratory and the Institute of Cancer Research, and a non-executive director at Ashford and St Peter's NHS Trust.

He is a serial entrepreneur and angel investor whose venture portfolio has raised more than £0.5 billion in capital finance.

Mr Devonshire was previously an entrepreneur in residence at the Department for Business, Energy and Industrial Strategy.

**Resolution 6: Re-appointment of Miss C A McAnulty as a Director**

Miss Cecilia McAnulty CA was appointed to the Board in September 2014. She is the senior independent non-executive director and a member of the audit committee, the nomination committee and the management engagement committee.

Miss McAnulty is an experienced board director and audit chair. She is currently a non-executive director of RIT Capital Partners plc, Polar Capital Financials Trust plc and Eurobank Cyprus, an EU regulated bank. She held senior investing roles at Centaurus Capital, a London based hedge fund, Barclays Capital and Royal Bank of Scotland.

**Resolution 7: Re-appointment of Miss R K Ramparia as a Director**

Miss Ranjan Ramparia was appointed to the Board in May 2022. She is chair of the audit committee and a member of the nomination committee and the management engagement committee.

Miss Ramparia is a qualified Chartered Accountant and experienced business professional. She started her career with PricewaterhouseCoopers in the audit, valuations and corporate finance divisions. Her early career was as a fund manager and she has experience of investing in listed and unlisted equities. She brings significant experience of regulatory and compliance matters and has served on the boards of regulated companies.

She also serves as a non-executive director of JPMorgan Global Emerging Markets Income Trust plc.

**Resolution 8: Appointment of Mr T Chambers as a Director**

Mr Chambers was appointed to the Board on 19 June 2024. He is a member of the audit committee, nomination committee and the management engagement committee.

Mr Chambers has had a range of industry and venture capital roles giving insight into, in particular, the technology and communications sectors. He is currently chair of Propel London (recruitment), a trustee of UCAS (Universities and Colleges Admissions Services) and an adviser to several private companies. Until 5 June 2024, he was a director of Kings Arms Yard VCT PLC and until 2018 chair of First Utility (Shell Energy). Previously, he played a significant role in the creation of the first Smartphones as CFO and Head of Software Engineering at mobile operating systems provider Symbian. He was also CFO at Robert Walters and spent six years in corporate finance at Dresdner Kleinwort Benson after five years with Price Waterhouse. He is a Fellow of the Institute of Chartered Accountants, an Associate of the Association of Corporate Treasurers, a Fellow of the Institute of Engineering and Technology and is an Honorary Doctor of the University of Surrey.

**Resolution 9: Re-appointment of Forvis Mazars LLP as independent auditor**

The Company is required by law to appoint an auditor at its Annual General Meeting. Shareholders are invited to vote to re-appoint Forvis Mazars LLP as independent auditor of the Company until the conclusion of the next annual general meeting of the Company.

**Resolution 10: Authority to fix the independent auditor's remuneration**

Shareholders are invited to vote to give the audit committee authority to fix the independent auditor's remuneration.

**Resolutions 11 and 12: Authority to allot shares and disapplication of Shareholders' statutory pre-emption rights****Resolution 11: General authority to allot shares**

Shareholders are being asked, under the Act, to grant the Directors a general authority to allot shares in the Company. This Resolution, if passed, gives the Directors authority to allot Ordinary Shares up to a maximum nominal value of £2,260,517.75 (representing 20% of the issued ordinary share capital of the Company at the date of the notice convening the Annual General Meeting). No shares are currently held in treasury.

This authority will be effective until the conclusion of the next annual general meeting of the Company to be held in 2025 or, if earlier, the date falling 15 months after the date of Resolution 11, except insofar as commitments to allot shares have been entered into before that date. The Directors have no present intention of exercising the authority granted by Resolution 11 except in connection with the issue of Ordinary Shares pursuant to the Company's dividend investment scheme.

**Resolution 12: General disapplication of pre-emption rights**

This Resolution supplements the Directors' general authority to allot shares in the Company given to them by Resolution 11 and authorises the Directors to allot Ordinary Shares, or sell treasury shares, for cash (otherwise than pro rata to existing Shareholders) up to an aggregate nominal value of £2,260,517.75 (representing 20% of the issued ordinary share capital of the Company at the date of the notice convening the Annual General Meeting).

Resolution 12 will be proposed as a special resolution.

This authority will be effective until the conclusion of the next annual general meeting of the Company to be held in 2025 or, if earlier, the date falling 15 months after the date of Resolution 12, save that the Directors may so allot Ordinary Shares or sell treasury shares in pursuance of an offer or agreement entered into before the authority expires.

**Resolution 13: Purchase of own shares**

Under the Act, this Resolution authorises the Company to purchase in the market up to 22,605,177 Ordinary Shares (representing 10% of the issued ordinary share capital of the Company at the date of the notice convening the Annual General Meeting) at a minimum price per share of 5p (excluding expenses) and a maximum price per share of not more than 105% (excluding expenses) of the average market value of the relevant shares for the five business days prior to the date on which the purchase is made.

Unless previously renewed, varied or revoked, the authority will be effective until the conclusion of the next annual general meeting of the Company to be held in 2025 or, if earlier, the date falling 15 months after the date of Resolution 13.

Purchases of Ordinary Shares will be made only within the guidelines established and to be reviewed from time to time by the Directors and where it is considered that such purchases would be to the advantage of the Company and its Shareholders as a whole. It is the Directors' intention that purchases will be made in the market for cash only at prices below the prevailing net asset value per share, thereby enhancing the net asset value per share for the Company's remaining Shareholders. Purchases will be financed from the Company's own cash resources or, if appropriate, from short term borrowings.

The cap on the price payable contained in the proposed Resolution reflects a restriction on the Company contained in the Listing Rules. In addition, under the Listing Rules the Company must not purchase shares at a price greater than the higher of the last independent trade and the highest current independent bid on the market where the purchase is carried out.

There are no existing Ordinary Shares covered by options or warrants at the date of publication of this document.

The Company's current intention is to cancel any repurchased shares but retains the flexibility to hold any repurchased shares as treasury shares, if it considers this to be in the best interests of the Company.

Resolution 13 will be proposed as a special resolution.

- 1 A member entitled to attend and vote at this meeting is entitled to appoint another person as his or her proxy to exercise all or any of his or her rights to speak and on a poll, to vote in his or her stead at the meeting. Changes to entries on the register after 6.30pm on 29 July 2024 (or after 6.30pm on the day which is two working days before any adjourned meeting) shall be disregarded in determining the rights of any person to attend or vote at the meeting.
- 5 As at 27 June 2024 (being the last business day prior to the date of this notice) the Company's issued share capital consisted of 226,051,775 ordinary shares each carrying one vote per share. Accordingly, the total number of voting rights in the Company as at 27 June 2024 was 226,051,775.
- 6 CREST members who wish to appoint a proxy or proxies for the meeting or any adjournment thereof by utilising the CREST electronic proxy appointment service may do so by following the procedures described in the CREST Manual ([www.euroclear.com](http://www.euroclear.com)). However, any member holding 3% or more of the voting rights in the Company who appoints a person other than the Chair as proxy will need to ensure that both the member and the proxy comply with the respective disclosure obligations under the DTRs.
